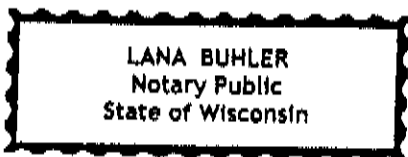

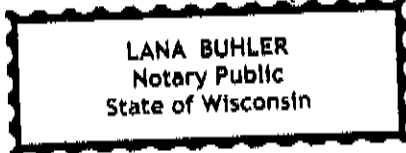

Red Apple School Chief Inspector Celeste WALKER

Mrs. Theresa Dixon and I arrived at Red Apple about 12:45, 8th November 2022. We noticed immediately that the observation area was completely wrong and was in the far NW corner of the gym and was off to the west edge of the check-in table. (It was also set up that way in August 2022, and I had made a complaint the previous visit about it). My complaint was ignored at that time. In defense of the City Clerk Ms. Tara McMenamam had sent out set-up instructions that Ms. Walker didn't follow because of issues about access to electrical service for the Badger Books. This was understandable and I suggested a suitable solution which would merely require a relocation of the voter ballot collection table and that the Badger Books table could remain in its current location. It would even make the room flow better for the voters as they arrived. It took several hours and a visit from our lawyer; but Ms. Walker cleared it with the City Clerk, and it was reasonably satisfactory. However, this location also had a strict policy of no chairs to be provided for the observers, nor access to restrooms! (BTW every other public school used in the city that day provided access to restrooms and chairs, except for Gilmore Middle School). ALL those schools are owned by the same organization; RUSD. I took the liberty of calling the principal's office at Red Apple, I spoke to a very helpful staffer who said that she'd send down the custodian with a half dozen chairs, further that if we needed to use the restrooms they were just down the stairs and around the corner and we were welcome to use them. I did in fact have a need to use the restroom and announced I was heading to use the restroom. Ms. Celeste Walker said I was forbidden from using the RR, I explained I had cleared it with the staff, and just at that moment the custodian arrived to ask where to place the chairs for our observers. Ms. Walker said they were refused, and she would not permit them to be placed. I then explained we had arranged for permission as well. But she would not relent. I then proceeded towards the restroom, only to find Ms. Walker at the top of the stairs. I said excuse me, and she refused to allow me to go down the steps to use the restroom. Again, I explained I had cleared permission from the office staff of the school. She continued to refuse me access and even blocked the pathway with her arms spread! As if I was trying to cross into the forbidden valley!

As a taxpayer, a voter, an observer I am just appalled that this and on other Chief Election Inspectors abused their authority in order to specifically disallow the use of chairs and prohibited access to restrooms. If Ms. Walker can't be courteous enough to provide a few basic conveniences for our poll observers, she should be removed at once from being a Chief Election Inspector in the city of Racine. Once an observer signs in, he/she become part of the process.

Voters must ask the question what is the purpose of this harassment? The only explanation being that we should make observation uncomfortable and inconvenienced, so that observers will find it not worth the hassle! Thus, preventing the staffers from running a shoddy, or even an illegal process. Racine is a city that has a long and deep history of election fraud, and carelessness; from the famous white vans of Chicago to Zuckerbucks. Our city should embrace volunteers and welcome the witness project. After all what are they hiding? I am sure there will be complaints recorded for the city and the County Clerks of our visit that day. I know other observers will be providing testimony on this location as well.
