**Re:** Complaint Filed with the Wisconsin Elections Commission:  
(EL 25-09) Kenneth Wolfe v. Renee Brickner

Dear Clerk Brickner:

Attached to the email transmitting this notice, please find a formal Wisconsin Statute § 5.06 complaint filed with the Wisconsin Elections Commission (Commission) by Kenneth Wolfe. The complaint alleges multiple statutory violations regarding the conduct of the 2024 General Election, including Wis. Stats. §§ 5.25(4)(a), 5.35(3), 6.03(1)(b), 6.29(2)(am), and 7.15(1)(a), (c), and (cm), and 7.15(14).

Individuals that believe the actions of an election official were contrary to an election law or were an abuse of discretion in applying an election law may file a complaint with the Commission. As the Respondent, you may now provide a sworn written response to the complaint within 13 business days of the date appearing on this letter, which is **February 6, 2025**. Your response should address the allegations raised in the complaint.

After you file your response, the Complainant may file a reply within 13 business days of the date that the Commission transmits your response to the Complainant. Once all allowable filings have been received, Commission staff will review the information and draft a decision letter for the Commission's consideration and decision at an upcoming meeting.

You may file your response via email addressed to [brandon.hunzicker@wisconsin.gov](mailto:brandon.hunzicker@wisconsin.gov) and [elections@wi.gov](mailto:elections@wi.gov) so long as it is clear that the original document has been sworn before an individual that can administer oaths, like a notary public, or that it contains an unsworn declaration.
