Wisconsin Elections Commission: Nomination Paper Review Guidelines

Process Overview

- Use a red pen to mark up the petition during the review process.
- Circle any piece of information on the petition page that is missing or problematic.
- Make a red check to the right of the row to indicate a signature should not be counted.
- Make a red question mark (?) to note questionable signatures that have been counted or to note omitted information on signature line where that signature is still able to be counted.
- Write the number of signatures counted on the upper, right-hand corner of each sheet.

Step 1: Review the Header

Overview: The header of each petition page must contain all the required candidate information. If any of the required information is missing, or incorrect, no signatures on that page can be counted.

Required information:

- 1. Name of candidate
- 2. Residential address of candidate
 - a. Street number and street name (P.O. box addresses are not acceptable)
 - b. Municipality for voting purposes
 - c. State
- 3. Type of election
- 4. Election date
- 5. Title of office sought
- 6. Branch, district or seat number of office sought (if applicable)
- 7. Name of district in which candidate seeks office

Other information:

- 1. Mailing address (only required if different than residential address or voting municipality)
- 2. Zip code (may be present but not required)

Step 2: Review the Certification of Circulator

Overview: The Certification of Circulator section is completed after the signatures on that page have been collected. Each petition page must contain all the required circulator information, the circulator's signature and a certification date that is on or

after the latest date of a signer. If any of the required information is missing or incorrect, no signatures on that page may be counted. If missing circulator information can be determined from another section of the petition page, the signatures on that page should be counted. Most often this occurs when a circulator is also the candidate or has signed that page as an eligible elector.

Residency of Circulator: The circulator does not need to reside in the district represented by the candidate, nor do they need to be a resident of Wisconsin. All circulators must be otherwise eligible to register to vote in Wisconsin (18 years of age, U.S. citizen, not serving any portion of a sentence for a felony offense). They do not need to be registered to vote in Wisconsin or any other state to circulate nomination papers.

Required information:

- 1. Name of circulator Signatures on the page should be counted if the circulator printed their name on the line meant for their signature.
- 2. Address of circulator
 - a. Street number, street name and municipality If missing circulator address, including municipality, can be determined from another section of the petition page, the signatures on that page should be counted.
 - b. State and zip code are not required.
- 3. Date (month/day/year) All signatures must be dated within the circulation period. No signatures should be counted on a page where any portion of the date is missing.
- 4. Signature of circulator Signatures on the page should be counted if the circulator signed on the line that should have the printed name.

Step 3: Review the Body of the Petition

Required information:

- 1. Signature of elector
 - a. Signature does not need be legible.
 - b. Electors may sign with an "X" or other mark if that is their usual signature.
 - c. Signature does not need to be cursive.
- 2. Printed name of elector
 - a. A printed name must be present in addition to the signature of the elector.
 - b. If a possible printed name can be determined, the signature should be counted.

- c. If a printed name cannot be determined, the signature should be struck from the petition.
- 3. Residential Address
 - a. Street name and street number or rural route are required.
 - b. Rural address must also include box or fire number.
 - c. P.O. boxes are only allowed if they are listed in addition to the residential address information. Signatures where only a P.O. box has been provided should be counted if the municipality of residence is entirely in the district. Mark with a question mark.
 - d. Ditto marks are allowed if they follow a valid address and the signer is using those marks to indicate they also reside at that address.
 - e. If all or part of the required address information of a signer is missing but residency can be determined by information found in another section of that specific petition page, that signature should be counted. This generally occurs when the signer is also the candidate and/or the circulator and the missing information is in the header or the certification section. Indicate on the petition page where that information is located.
- 4. Municipality of Residence
 - a. Municipality listed must be within the district represented by the candidate.
 - b. Abbreviations are allowed (e.g. "FDL" for Fond Du Lac or "Milw" for Milwaukee).
 - c. Ditto marks are allowed if they follow a valid municipality and the signer is using those marks to indicate they also reside in the municipality.
 - d. The Town/Village/City check box does not need to be checked.
 - e. If the municipality of residence was provided in the Residential Address field, the signature should be counted.
 - f. If the municipality information of a signer is missing but residency can be determined by information found in another section of that specific petition page (most likely in the header or the Certification of Circulator), that signature should be counted. Indicate on the petition page where that information is located.
- 5. Date of Signing
 - a. A complete date includes the month/date/year.
 - b. Date must be within the circulation period.
 - c. Date must be on or before the date the page was certified by the circulator.

- d. Ditto marks are allowed if they follow a valid date and the signer is using those marks to indicate they also signed on the same date. If ditto marks are used for the date of the last signer, the signature can be counted if it follows a valid date.
- e. A missing date can be bracketed ([]) if valid and complete dates appear on the line above and the line below the signature line with the missing date.
- f. If the date of the first or last signer is incomplete, it cannot be bracketed, and that signature should not be counted.

Step 4: Count the Signatures

- 1. Sort the petition by the number of valid signatures on each page before determining the final number of valid signatures.
- 2. Place the pages with 10 counted signatures on top, followed by the pages with 9, etc.
- 3. Use a tally sheet or calculator to determine the number of valid signatures on the petition.
- 4. Determine if the number of valid signatures is sufficient for the office sought. Use the appropriate Ballot Access Checklist to determine the signature threshold for the office sought:

8.10 Nominations for spring election.

(1) Candidates for office to be filled at the spring election shall be nominated by nomination papers, or by nomination papers and selection at the primary if a primary is held, except as provided for towns and villages under s. 8.05. Unless designated in this section or s. 8.05, the general provisions pertaining to nomination at the partisan primary apply.

(2)

(a) Nomination papers for offices to be filled at the spring election may be circulated no sooner than December 1 preceding the election and may be filed no later than 5 p.m. on the first Tuesday in January preceding the election, or the next day if Tuesday is a holiday, except as authorized in this paragraph. If an incumbent fails to file nomination papers and a declaration of candidacy by the time prescribed in this paragraph, all candidates for the office held by the incumbent, other than the incumbent, may file nomination papers no later than 72 hours after the latest time prescribed in this paragraph. No extension of the time for filing nomination papers applies if the incumbent files written notification with the filing officer or agency with whom nomination papers are filed for the office which the incumbent holds, no later than 5 p.m. on the 2nd Friday preceding the latest time prescribed in this paragraph for filing nomination papers for that office within the time prescribed in this paragraph.

(am) If, under par. (a), an incumbent holding local office files written notification that the incumbent is not a candidate for reelection to his or her office or fails to file a declaration of candidacy within the time prescribed in par. (a), the officer or body with whom the declaration of candidacy is required to be filed shall promptly provide public notice of that fact on the officer's or body's Internet site or, if the officer or body does not maintain an Internet site, by posting notices in at least 3 different locations within the jurisdiction that the officer or body serves.

(b) Each nomination paper shall have substantially the following words printed at the top:

I, the undersigned, request that the name of (insert candidate's last name plus first name, nickname or initial, and middle name, former legal surname, nickname or middle initial or initials if desired, but no other abbreviations or titles), residing at (insert candidate's street address) be placed on the ballot at the (spring or special) election to be held on (date of election) as a candidate so that voters will have the opportunity to vote for (him or her) for the office of (name of office). I am eligible to vote in the (name of jurisdiction or district in which candidate seeks office). I have not signed the nomination paper of any other candidate for the same office at this election.

(c) Each candidate shall include his or her mailing address on the candidate's nomination papers.

(3) The certification of a qualified circulator under s. 8.15 (4) (a) shall be appended to each nomination paper. The number of required signatures on nomination papers filed under this section is as follows:

(a) For statewide offices, not less than 2,000 nor more than 4,000 electors.

(am) For court of appeals judges, not less than 1,000 nor more than 2,000 electors.

(b) For judicial offices not specified in pars. (a), (am), and (c), not less than 200 nor more than 400 electors.

(c) For judicial offices in counties over 750,000 population, not less than 1,000 nor more than 2,000 electors.

(cm) For county executives in counties over 750,000 population, not less than 2,000 nor more than 4,000 electors.

(cs) For comptrollers in counties with a population of at least 750,000, not less than 500 nor more than 1,000 electors.

(d) For county executives in counties between 100,000 and 750,000 population, not less than 500 nor more than 1,000 electors.

(e) For county executives in counties under 100,000 population, not less than 200 nor more than 400 electors.

(f) For supervisors in counties over 750,000 population, not less than 200 nor more than 400 electors.

(g) For supervisors in counties between 100,000 and 750,000 population, not less than 100 nor more than 200 electors, except as provided in sub. (3m).

(h) For supervisors in counties under 100,000 population, not less than 20 nor more than 100 electors.

(hm) For members of the metropolitan sewerage commission in districts over 1,000,000 population, not less than 1,000 nor more than 2,000 electors, in districts over 200,000 but not over 1,000,000 population, not less than 200 nor more than 400 electors, and in districts not over 200,000 population, not less than 100 nor more than 200 electors.

(i) For city offices in 1st class cities, not less than 1,500 nor more than 3,000 electors for city-wide offices, not less than 200 nor more than 400 electors for alderpersons elected from aldermanic districts and not less than 400 nor more than 800 electors for members of the board of school directors elected from election districts.

(j) Except as provided in par. (jm), for city offices in 2nd and 3rd class cities, not less than 200 nor more than 400 electors for city-wide offices and not less than 20 nor more than 40 electors for alderpersons elected from aldermanic districts.

(jm) For city offices in 2nd and 3rd class cities, not less than 100 nor more than 200 electors for alderpersons who are not elected from aldermanic districts.

(k) For city offices in 4th class cities, not less than 50 nor more than 100 for city-wide offices and not less than 20 nor more than 40 electors for alderpersons elected from aldermanic districts.

(km)

1. Except as provided in subd. <u>2.</u> and subject to sub. <u>(3s)</u>, for school district officer in any school district that contains territory lying within a 2nd class city, not less than 100 nor more than 200 electors.

2. For a school district officer in any school district described in subd. <u>1.</u>, not less than 20 and not more than 100 signatures if the annual meeting or the school board of the school district adopts a resolution to reduce the number of required signatures and if, on the date that the annual meeting or school board acts

under this subdivision, the territory of the school district lying within one or more 2nd class cities is less than or equal to 10 percent of the territory of the school district.

(ks) For school district officer in any school district which does not contain territory lying within a 1st or 2nd class city, if nomination papers are required under s. 120.06 (6) (a), not less than 20 nor more than 100 electors.

(L) For other offices, not less than 20 nor more than 100 electors.

(3m) The county board of any county having a population of at least 100,000 but not more than 750,000 may provide by ordinance that the number of required signatures on nomination papers for the office of county supervisor in the county is not less than 50 nor more than 200 electors. A county that enacts such an ordinance may repeal the ordinance at a later date. Any ordinance changing the number of signatures under this subsection takes effect on November 15 following enactment of the ordinance.

(3s)

(a) For a school district that does not contain any territory lying within a 2nd class city on April 18, 2018, the signature requirement for school district officer under sub. (3) (km) 1. first applies to a candidate for the office of school district officer filled in the 2nd spring election that follows the effective date of the event that causes the school district to have territory that lies within a 2nd class city.

(b) For a school district that has, by resolution, reduced the number of signatures required on nomination papers as permitted under sub. (3) (km) 2., the signature requirement for school district officer under sub. (3) (km) 1. first applies to a candidate for the office of school district officer filed in the 2nd spring election that follows the date of the event that causes the territory of the school district lying within one or more 2nd class cities to be greater than 10 percent of the territory of the school district.

(4)

(a) All signers on each nomination paper shall reside in the jurisdiction or district which the candidate named on the paper will represent, if elected.

(b) Only one signature per person for the same office is valid. In addition to his or her signature, in order for the signature to be valid, each signer of a nomination paper shall legibly print his or her name in a space provided next to his or her signature and shall list his or her municipality of residence for voting purposes, the street and number, if any, on which the signer resides, and the date of signing.

(5) Nomination papers shall be accompanied by a declaration of candidacy under s. 8.21. If a candidate has not filed a registration statement under s. 11.0202(1)(a) at the time he or she files nomination papers, the candidate shall file the statement with the papers. A candidate for state office or municipal judge shall also file a statement of economic interests with the ethics commission under s. 19.43(4) no later than 4:30 p.m. on the 3rd day following the last day for filing nomination papers under sub. (2) (a), or no later than 4:30 p.m. on the next business day after the last day whenever that candidate is granted an extension of time for filing nomination papers under sub. (2) (a).

(6) Nomination papers shall be filed:

(a) For state offices or seats on a metropolitan sewerage commission, if the commissioners are elected under s. 200.09 (11) (am), in the office of the elections commission.

(b) For county offices, in the office of the county clerk or board of election commissioners.

(**bm**) For municipal judge, if the judge is elected under s. <u>755.01 (4)</u>, in the office of the county clerk or board of election commissioners of the county having the largest portion of the population in the jurisdiction served by the judge.

(c) For city offices and other offices voted for exclusively within the municipality, except the office of county supervisor, in the office of the municipal clerk or board of election commissioners.

(d) For school district offices to be voted for within more than one municipality, with the person designated by the school board as the filing official for their school district.

(7) If a candidate submits nomination papers with more than the maximum number of required signatures prescribed under sub. (3), but the filing official determines that the maximum number of required signatures does not result in a sufficient number of valid signatures, the filing official shall review the additional signatures to the extent necessary to determine whether the candidate has collected a sufficient number of valid signatures.

(8)

(a) Notwithstanding sub. (2) (b) and (c) and s. 8.21 (4) (b), a candidate for filling the office of a judicial officer, as defined in s. 757.07 (1) (e), who files a certification of residence with the commission before circulating nomination papers is not required to indicate his or her residential address on the nomination papers, including nomination papers circulated on behalf of the judicial officer, or on the declaration of candidacy. Notwithstanding sub. (3) (intro.), a judicial officer, as defined in s. 757.07 (1) (e), who intends to circulate nomination papers on behalf of a candidate for filling a nonpartisan office, or who intends to sign nomination papers to support such a candidate, is not required to indicate his or her residential address on the certification of a qualified circulator appended to the nomination papers or on the nomination papers as a signatory. The commission shall promulgate rules for the administration of this subsection.

8.10(8)(b) (b) Certifications of residence submitted to the commission under par. (a) shall be kept confidential unless the judicial officer consents to disclosure under s. 757.07 (4) (e), except that the commission shall provide such certifications to the appropriate filing officer for the office the candidate or judicial officer seeks. Filing officers shall also keep confidential the certifications received by the commission unless the judicial officer consents to disclosure.

8.30 Candidates ineligible for ballot placement.

(1) Except as otherwise provided in this section, the official or agency with whom declarations of candidacy are required to be filed may refuse to place the candidate's name on the ballot if any of the following apply:

(a) The nomination papers are not prepared, signed, and executed as required under this chapter.

(b) It conclusively appears, either on the face of the nomination papers offered for filing, or by admission of the candidate or otherwise, that the candidate is ineligible to be nominated or elected.

(c) The candidate, if elected, could not qualify for the office sought within the time allowed by law for qualification because of age, residence, or other impediment.

(2) If no registration statement has been filed by or on behalf of a candidate for state or local office in accordance with s. 11.0202(1)(a) by the applicable deadline for filing nomination papers by such candidate, or the deadline for filing a declaration of candidacy for an office for which nomination papers are not filed, the name of the candidate may not appear on the ballot. This subsection may not be construed to exempt a candidate from applicable penalties if he or she files a registration statement later than the time prescribed in s. 11.0202(1)(a).

(2m) The official or agency with whom nomination papers and declarations of candidacy are required to be filed shall not place a candidate's name on the ballot if the candidate's name is ineligible for ballot placement under s. 5.05 (2m) (d) 2., 15.61 (3), or 19.49 (2) (c) 2.

(3) The official or agency with whom declarations of candidacy are required to be filed may not place a candidate's name on the ballot if the official or agency is prohibited from doing so under s. $\underline{19.43}$ (4) or an ordinance adopted under s. $\underline{19.59}$ (3) (b).

(4) The official or agency with whom a declaration of candidacy is required to be filed may not place a candidate's name on the ballot if the candidate fails to file a declaration of candidacy within the time prescribed under s. 8.21.

MEMORANDUM

SUBJECT: Ballot Access for the April 1, 2025, Spring Election

This memorandum presents a summary of noteworthy information about candidates requesting ballot access for the April 1, 2025, Spring Election.

<u>Summary</u>

The nomination paper filing deadline for the 2025 Spring Election for the offices of State Superintendent of Public Instruction, Justice of the Wisconsin Supreme Court, Court of Appeals judge in Districts II, III and IV, and for circuit court judge in various counties, was 5:00 p.m. on Tuesday, Jan. 7, 2025. The circulation period for nomination papers began on Dec. 1, 2024.

A total of 59 candidates registered for state office contests in the Spring Election, 56 of whom filed nomination papers with the Wisconsin Elections Commission. There are three candidates for State Superintendent of Public Instruction, two candidates for Supreme Court, one candidate for Court of Appeals judge District II, one candidate for Court of Appeals judge District III, one candidate for District IV, and 48 candidates for 38 circuit court judge positions in 21 counties.

The first nomination papers were filed on Dec. 12, 2024, and two sets of papers were filed on deadline day.

The office of State Superintendent of Public Instruction, Jefferson County Circuit Court Branch 2 and St. Croix County Circuit Court Branch 2 are the state-level offices that will potentially require a primary on Feb. 18, 2025. At the time of printing, one challenge has been filed against a candidate running for Jefferson County Circuit Court Branch 2. If additional challenges are filed with the Commission ahead of the January 10, 2025, 4:30 p.m. deadline, staff will update the Commission. Notifications of Noncandidacy

A Notification of Noncandidacy may be filed by an incumbent who is not seeking re-election to the office he or she currently holds. If an incumbent fails to file a Notification of Noncandidacy by the second Friday before the filing deadline - and does not file ballot access documents by the filing deadline - the filing deadline is extended 72 hours for any other candidate for that office. The extension does not apply to the incumbent. Wis. Stat. § 8.10(2)(a). The second Friday before the Jan. 7, 2025, filing deadline fell on Dec. 27, 2024.

Staff reached out to incumbent officeholders to ensure that those who did not plan to run for re-election filed a Notification of Noncandidacy by the deadline so that the ballot certification and preparation process was not delayed. Seven incumbent officeholders timely filed Notifications of Noncandidacy (see Attachment A). All other incumbents submitted nomination papers. Therefore, no extension of the filing deadline was required for offices for which the Commission is the filing officer.

Nomination Paper Review Process

Staff apply nomination paper review standards based on Wis. Stats. §§ 8.10 and 8.30 and Wis. Admin. Code Ch. EL 2 to determine if a candidate has filed a sufficient number of signatures to qualify for ballot access. Attached to this memorandum are the internal nomination paper review standards (Attachment C) and the relevant statutory provisions (Attachment D) used by staff when reviewing papers. Staff also rely on past practices when making recommendations to the Commission as to whether an error on a nomination paper is grounds for striking a signature or page of signatures. This body of precedent comes from decisions issued regarding challenges to nomination papers, or a compliance review complaint filed under Wis. Stat. § 5.06. Staff accept all petitions under the presumption of validity as described in Administrative Code EL 2.05(4).

Number of Nomination Paper Signatures Required

- Candidates for State Superintendent of Public Instruction must file a minimum of 2,000 valid signatures of qualified electors of Wisconsin to qualify for ballot access. Wis. Stat. § 8.10 (3)(a).
- Candidates for Justice of the Supreme Court must file a minimum of **2,000** valid signatures of qualified electors from Wisconsin to qualify for ballot access. Wis. Stat. § 8.10 (3)(a).
- Candidates for court of appeals judge must file a minimum of **1,000** valid signatures of qualified electors from the district to qualify for ballot access. Wis. Stat. § 8.10(3)(am).
- Candidates for circuit court judge in counties over 750,000 in population (Milwaukee County) must file a minimum of 1,000 valid signatures of qualified electors from the district to qualify for ballot access. Wis. Stat. § 8.10(3)(c).
- Candidates for circuit court judge in counties with a population of 750,000 or less must file a minimum of 200 valid signatures of qualified electors from the district to qualify for ballot access. Wis. Stat. § 8.10(3)(b).

Every nomination paper was reviewed separately by two staff members, and a determination regarding initial sufficiency was made within one business day of submission. This satisfied the staff goal of performing the two reviews within two business days of receiving the nomination papers. Out of 56 nomination paper submissions, 55 contained a sufficient number of valid signatures. One candidate has made plans to file a correcting affidavit to bring his nomination paper submission up to the minimum 200 signatures ahead of the Friday deadline, but has not filed such an affidavit as of 12:00 p.m. on January 10, 2025. As of the deadline for filing nomination papers (Tuesday, Jan. 7, 2025, at 5:00 p.m.), 30 candidates had also filed additional nomination papers to supplement their original filings.

Nomination Paper Copy Requests

To facilitate requests for copies of nomination papers, staff made candidate petitions available for download via the Badger Voters data request site (<u>https://badgervoters.wi.gov/</u>). After the review process was complete, each petition, Declaration of Candidacy, and any supplemental signatures were scanned and uploaded to the site. These documents are available for download at no cost to the requestor. As of Jan. 9, 2025, 105 requests for nomination paper files had been fulfilled through Badger Voters.

Irregularities on Nomination Papers and Ballot Access Documents Not Affecting Ballot Status

One irregularity was detected by staff during the nomination paper and ballot access document review process. Consistent with prior practice and decisions, staff believes this irregularity does not affect ballot access and did not strike signatures or reject filed documents due to this issue. Samples of the issue are in Attachments E.

1. Printed names of signers on nomination papers appear to be written by the circulator.

Staff continue to find printed names of signers and address information that appear to be in the same handwriting as the circulator, although there were fewer instances noticed during this filing period. Wis. Stat. § 8.10 (4)(b) requires the printed name and address information to be made by the signer of the petition, unless the signer requests assistance in signing or printing their name and address. Although staff encounter sporadic examples of this practice on many sets of papers, the most consistent examples over time involve circulators for candidates for Milwaukee County Circuit Court Judge, some of whom are judges themselves. Without a verified challenge, staff do not believe that their own handwriting determinations were sufficient to strike signatures on that basis alone. Handwriting analysis is subjective, and just because handwriting looks similar, that does not mean it was done by the same person. However, even if staff had struck signatures to attain ballot access. Staff will continue to remind circulators that they can only assist a signer in providing such information if it is specifically requested by the signer.

Statements of Economic Interests

All candidates timely filed the Statement of Economic Interests with the Wisconsin Ethics Commission.

Challenges to Nomination Paper Sufficiency

One challenge to ballot access was received at the time of printing. The deadline to file a challenge to ballot access is Jan. 10, 2025, at 4:30 p.m. Challenges will be discussed in a separate memorandum and presented by staff counsel.

Candidates Recommended for Approval of Ballot Status

Staff recommend that the Commission certify ballot access for the 56 candidates listed as "approved" in Attachment B, Candidate Tracking by Office report.

Staff Recommendations for Approval of Ballot Access

A list of candidates recommended for ballot status is included with this memorandum (Attachment B). Staff request the Commission approve the ballot status of those candidates listed who have met or exceeded the minimum valid signatures and have filed all necessary ballot access documents. Candidates that the staff have determined meet the required ballot access requirements are marked as "approve" on Attachment B.

This list includes candidates whose nomination papers contain issues that could support a challenge (such as form template issues, imprecise but common replacements for office titles, and suspiciously similar handwriting). However, during its review, Commission staff determined that the nomination papers nevertheless substantially complied with all requirements under the applicable laws and administrative code provisions.

Recommended Motion #1: The 56 candidates marked "approve" on the "Candidates Tracking by Office" report are approved for ballot access for the April 1, 2025, Spring Election, in addition to any candidates who were subject to challenge but were ultimately approved for ballot access by the Commission.

Staff Recommendations for Denial of Ballot Access

Staff requests the Commission deny the ballot status of those candidates listed who have not met the minimum number of valid signatures, have not filed all necessary ballot access documents or otherwise do not meet the statutory requirements to be placed on the ballot. Candidates that staff have determined do not meet the required ballot access requirements are marked as "deny" on Attachment B.

Recommended Motion #2: The three candidates marked "deny" in Attachment B are denied ballot access for the April 1, 2025, Spring Election, in addition to any candidates who were subject to challenge and were ultimately denied ballot access by the Commission.

Challenges to Ballot Status

The deadline for challenges to ballot access was Friday, Jan. 10, 2025. One challenge was filed with the Commission at the time of printing.

Introduction

On July 1, 2025, a new provision of Wisconsin public records law will go into effect regarding Identities of Election Officials or Election Registration Officials ("the Election Official Identity Statute"). Wis. Stat. § 19.36(14). This provision of law will impact all units of state and local government, including the Commission, county clerks, and municipal clerks.

The Election Official Identity statute consists of a single sentence: "Unless access is specifically authorized or required by statute, an authority shall not provide access under s. 19.35 (1) to records containing the personally identifiable information of an election official, as defined in s. 5.02 (4e), or an election registration official, as defined in s. 5.02 (4g), except that an authority may provide access to the name of an election official or election registration official and the city and state where the official resides."

Discussion

There are many ambiguities with the Election Official Identity Statute that make assessing compliance difficult. First, there are difficulties with understanding its scope, specifically whether the records need to identify the individual as a current election official for this statute to apply. Second, it is not clear what information must be protected when the statute does apply because the term "personally identifiable information" is not defined. Finally, it is not clear how the Commission can, or must, comply with both this statute and the state laws that require public access to the statewide voter registration list.

Commission staff believe that an opinion from the Attorney General is warranted to better understand how the Commission and other government offices can best comply with this new provision. The Attorney General is authorized by statute to give his opinion on all questions of law submitted by the head of any department of state government, and he is also specifically authorized to give his opinion on questions of interpretation of Wisconsin's public records law. Wis. Stats. §§ 165.015 and 19.39.

Thomsen Commission staff believe the Commission is the appropriate requestor for an attorney general opinion on this statute because even though it is a provision of public records law, not election law, its subject matter will likely lead other units of government to turn to the Commission for questions. Specifically, other units of government across the state might believe that the Commission maintains or possesses a list of all election officials in the state, and they may see requesting such a list as a significant aid to complying with the law. Such a list does not exist, meaning the Commission is likely to receive many questions on how public records officers are supposed to determine if an individual mentioned in a record is an election official.

Without clarity from the Attorney General, the Commission will likely need to interpret this provision of law itself, including the degree to which it can comply. Strict compliance with the statute, meaning all ambiguities are resolved in favor of protecting information, would be extremely burdensome on existing systems and practices. Difficulties with this statute are not unique to the Commission—every unit of government that handles public records requests will run into the same ambiguities.

Additional details regarding the necessity of this Attorney General opinion, as well as the proposed questions of interpretation, are laid out in the draft included in **Attachment A**.

<u>Recommended Motion</u>: The Wisconsin Elections Commission approves the draft in **Attachment A**, subject to any revisions or edits that received consensus during the discussion. Staff are directed to transmit the final request to Attorney General Josh Kaul pursuant to Wis. Stats. §§ 165.015 and 19.39.

Dear Attorney General Kaul:

Pursuant to Wis. Stat. § 165.015, the Wisconsin Elections Commission ("the Commission") respectfully requests your opinion in writing upon a question law pertaining to the interpretation and implementation of newly created Wis. Stat. § 19.36(14), Identities of Election Officials or Election Registration Officials ("the Election Official Identity Statute"). Since the statutory change was made to Chapter 19, the Commission also makes this request pursuant to Wis. Stat. § 19.39, which permits any person to request advice from the attorney general as to the applicability of any subchapter within Chapter 19. This statutory change will become effective as of July 1, 2025, and was passed pursuant to 2023 Wisconsin Act 126.¹

The Election Official Identity statute consists of a single sentence: "Unless access is specifically authorized or required by statute, an authority shall not provide access under s. 19.35 (1) to records containing the personally identifiable information of an election official, as defined in s. 5.02 (4e), or an election registration official, as defined in s. 5.02 (4g), except that an authority may provide access to the name of an election official or election registration official and the city and state where the official resides."

However, unless the Commission receives clarity from the Attorney General, this single sentence has the potential to disrupt the work of the Commission and other administrative agencies, as well as every municipality and county in the state, by setting an unreasonable and unworkable standard by which election official information must be redacted or withheld from public records requests.

Although the content of the law (election officials) appears on its face to be within the Commission's statutory purview, the broader questions actually stem from and impact Wisconsin public records law. Commission legal staff have already fielded questions from other municipal attorneys who represent Wisconsin cities, towns, and villages who are also concerned over the applicability and feasibility of complying with the Election Official Identity Statute. Many state agencies or local governments may be under the impression that the Commission maintains a list or database of every election official in the state, but that is not the case. Accordingly, the Commission believes the Attorney General's interpretations are not only appropriate because of the statewide significance of the law, but also because the Attorney General has published and maintained the Wisconsin Public Records Law Compliance Guide for many years.

Commission staff estimate that it would take 10 to 12 weeks, at minimum, to develop and implement changes to the statewide voter registration system to comply with the Election Official Identity Statute by July 1. Any number of factors could increase that estimate, so the Commission respectfully requests your opinion on these questions as soon as possible, but no later than **February 14, 2025**.

Statutory Background

The Election Official Identity statute was added to a larger piece of legislation addressing local candidate filings with the Wisconsin Ethics Commission. It was added as an Assembly Amendment 1 to 2023 Senate Bill 822 as part of a series of additions designed to offer greater protection to election officials, including whistleblower protections, as well as creating the new crime of battery to an election official.

The Election Official Identity statute creates a new provision within Chapter 19, Subchapter II, which covers Public Records and Property. Specifically, it creates a new limitation upon access and withholding of public records. The purpose of the law is to protect the personally identifiable information of election officials (any individual who is charged with duties relating to the conduct of an election) and election registration officials (any official assigned under state law to register electors). Under the Election Official Identity statute, a public records custodian is only permitted to provide access to an election official's name, city, and state, and cannot provide any other personally identifiable information.

Questions Presented

<u>Question 1</u>: The Commission seeks your opinion on whether the record needs to identify the individual as an election official for the records custodian to be required to withhold their personally identifiable information.

The most significant ambiguity in the Election Official Identity statute is its intended scope of applicable records, and whether the record must identify an individual as an election official for the Election Official Identity statute to apply. The Commission believes that the record itself must identify an individual as an election official. Any interpretation to the contrary would create an unworkable and unreasonable compliance standard for not only the Commission, but also every other state agency and local unit of government in Wisconsin.

The Election Official Identity statute indicates that the information that must be withheld is the "personally identifiable information *of an election official*..." (Emphasis added). The only way for the records custodian to determine if the Election Official Identity statute applies is if the record itself tells them that it does. There is no repository or statewide list of every election official in the state. The Commission estimates that there could be upwards of 30,000 individuals who serve as local election officials (mostly poll workers) during a major general election.

Even if there were some kind of central repository that listed every individual who has ever served as an election official, checking it against each and every name that appears on a requested public record would likely grind every public records office in the state to a halt.

As an example, consider the following hypothetical scenario. A state agency identifies a responsive record that contains the name and residential address of Bucky Badger, who resides in Appleton, Wisconsin. The record is responsive to the request and is otherwise releasable under Wisconsin public records law. However, in the wake of the Election Official Identity statute, the agency now must determine if Bucky Badger is an election official so that it can then determine if the residential address must be redacted. If the record itself does not identify Bucky Badger as an election official, the agency has a tough job ahead of it since there is no statewide database of election officials.

First, the agency could try to determine if Bucky Badger is a municipal clerk or county clerk. That is a relatively simple matter as the agency could verify with the Commission whether someone is a current clerk. However, since clerks are not the only types of election officials, the work must continue. Second, to determine if Bucky Badger is or has ever been a poll worker, the agency must contact the municipal clerk associated with Bucky's address. Then the agency must wait for the municipal clerk to search their own records to confirm if Bucky is in fact a poll worker. But what if Bucky just moved to Appleton? What if he was a poll worker in Sun Prairie before that? How is the agency supposed to know that? At this point, the agency has likely expended a considerable amount of time trying to figure out if Bucky Badger is, or has ever been, an election official, so now the agency is at risk of not fulfilling the request "as soon as practicable and without delay." Wis. Stat. § 19.35(4).

Next, consider a related hypothetical scenario that takes an already daunting task and increases the difficulty exponentially. Agencies and local governments receive and generate emails every day from Wisconsin residents that do not necessarily identify where the individual resides or whether that individual is an election official somewhere in the state. If Bucky Badger sent an email to a state agency or local government supporting or opposing a policy, that email address would likely be personally identifiable information, but likely would not provide enough information for the public records officer to know even which clerk to contact to check if the individual is an election official. Even if there were a statewide repository of election official names, it might not be possible to determine whether the Bucky Badger who sent the email is the same as the Bucky Badger who was a poll worker in Sun Prairie earlier this year. A records officer may have no other method but to individually contact each person who would have personally identifiable information revealed in a public record set for release to determine whether the information must be redacted. A large records request might contain hundreds of names and emails, which would create a nearly impossible situation to review for redactions of election official information.

The Commission does not believe that this was the outcome envisioned or intended by the Legislature. Considering that other provisions that were included alongside the Election Official Identity statute were designed to protect election officials (whistleblower protections and a new crime for battery of an election official), it is more likely that the Legislature intended to protect records that identify election officials as such, and that include their personally identifiable information. In other words, it seems as if the Legislature intended to protect a document, such as a list of poll workers, labeled as such, from falling into the hands of someone motivated to use that list to harass, threaten, or intimidate election officials.

If you agree that a record must identify an individual as an election official for the Election Official Identity statute to apply, the Commission seeks your opinion on the necessary follow up question of *how* the record must identify the election official.

<u>Question 2</u>: If your opinion to Question 1 is that the record must identify the individual as an election official, is it also your opinion that the record must identify the individual as a <u>current</u> election official?

The Election Official Identity statute specifically cross-references the statutory definitions for "election official" and "election registration official." Wis. Stats. §§ 5.02(4e) and 5.05(4g). The Commission has consistently interpreted these definitions to refer to current election officials, not former, because only current election officials are authorized to administer elections. Accordingly, the Commission seeks your opinion on whether someone who once was, but is no longer, charged with duties to register or carry out elections is not an election official, and is therefore not protected by the Election Official Identity statute.

Similar to Question 1, if you agree that a record must identify an individual as a current election official for the Election Official Identity statute to apply, the Commission seeks your opinion on the necessary follow up question of *how* the record must indicate that the individual is a current election official.

<u>Question 3</u>: The Commission seeks your opinion on what information constitutes "personally identifiable information" for election officials, and whether that includes government email addresses or phone numbers.

The Election Official Identity statute requires records custodians to withhold records containing the "personally identifiable information" ("PII") of an election official without further defining what constitutes PII in this context. Generally, under public records law, PII "means information that can be associated with a particular individual through one or more modifiers or other information or circumstances." Wis. Stat. § 19.62(5). The Election Official Identity statute specifically includes the names of election officials, as well as the city or state where they reside, but it is silent with respect to what other information should be withheld or redacted.

Under the broadest reading of the Election Official Identity statute, a records custodian would be compelled to withhold or redact almost every record containing information about an election official. This could include: government email addresses, government phone numbers, personal email addresses or phone numbers, family information, education background, or any other piece of information that can be associated with the individual. Even if the Election Official Identity statute were limited to current election officials only, needing to manually redact every email address, phone number, or other piece of identifying information would exponentially increase the time needed to review and redact records.

Accordingly, the Commission seeks your opinion on whether "personally identifiable information" within the Election Official Identity statute has the same meaning as in § 19.62(5), or whether it has some different meaning specific to election officials.

<u>Question 4</u>: The Commission seeks your opinion on whether Wis. Stat. § 6.36(1)(b)1. constitutes access that is "specifically authorized or required by statute" under the Election Official Identity statute.

The entirety of the Election Official Identity statute is predicated upon its prefatory clause, "unless access is specifically authorized or required by statute." The Commission seeks the Attorney General's interpretation of this phrase, specifically as it relates to state law requiring the Commission to permit public access to the statewide voter registration list.

The prefatory phrase "unless access is specifically authorized or required by statute" appears in two other places in Chapter 19. Wis. Stat. §§ 19.36(10) (employee personnel records); and 19.36(11) (records of an individual holding a local public office or state public office). The Commission was unable to find any court case in Wisconsin interpreting this phrase within the context of Chapter 19, and the Department of Justice's Wisconsin Public Records Law Compliance Guide is likewise silent on the matter.

State law requires the Commission to compile and maintain the statewide voter registration list, which must include, among other things, the electors': 1) name and address; 2) date of birth; and 3) driver's license number (if any) or last four digits of a social security number. Wis. Stat. § 6.36(1)(a)(1), (2), and (5). State law also requires that this list "be open to public inspection" and "be electronically accessible." Wis. Stat. § 6.36(1)(b)1. State law exempts the public from accessing electors' dates of birth, driver's license numbers, social security numbers, protected confidential elector addresses, or requested accommodations. Wis. Stat. § 6.36(1)(b)1.a. However, § 6.36(1)(b)1.a. does not prevent the Commission from making the residential addresses of electors publicly available on the statewide voter registration list.

The Commission believes that the most common sense read of this prefatory clause means that the Election Official Identity statute would not apply to the statewide voter registration list because the Commission is "specifically authorized or required by statute" to make the list publicly available.

Conclusion

In order for the Commission to have enough time to implement new processes and possible changes to election systems ahead of when the law goes into effect on July 1, 2025, the Commission respectfully requests your opinion on these questions no later than February 14, 2025.
